### "Only You Can Prevent Forest Fires!" Fire Safety Recommendations:

In light of the recent numerous fires experienced here recently on the Front Range, we'd like to take a moment to remind everyone of some critical fire safety recommendations:

- 1. Ensure that your smoke alarms are working by testing them frequently and notify Thistle Management immediately if any of your smoke alarms are not working properly.
- 2. Teach everyone in the household what smoke alarms sound like, and what to do when they hear one.
- 3. Ensure that all doors and points of egress are clear and accessible.
- 4. Ensure that all household members know two ways to escape from every room of your home and identify a family meeting spot outside of your home.
- 5. Practice an emergency evacuation plan at least twice a year. Press the smoke alarm test button, or yell "Fire!" to alert everyone that they must get out.
- 6. Ensure that all appliances (i.e.: ovens and stovetop burners) are turned off immediately after use.
- 7. Avoid using ANY item that could cause a spark.

#### Animal Leash Laws Reminder:

Due to an uptick of complaints received regarding animals off-leash and other animal behavior, we'd like to take the opportunity to remind all Residents of the City rules and regulations:

#### Per the City Animal Laws:

- Dogs MUST be on a hand-held leash at all times.
- Dogs must not be tied up outside, or left outside unsupervised, including on patios, balconies, or in common spaces (ie: the tennis court).
- Owners must pick up animal waste immediately. Failure to immediately and properly dispose of

animal waste can result in a fine of \$100.00 from the City of Boulder.

Additionally, the Thistle Pet/Service Animal Agreement states that "pets will not disturb any of the other Residents and will not damage any of the property of the apartment community". Please be respectful of your neighbors by preventing barking or excessive noise from your pets or animals, especially during the quiet hours of 10:00pm—6:00am.

All maintenance emergencies must be reported by calling our 24-hour On-Call Maintenance line at (303)443-0007 ext. 2.

Please note that staff emails and office phone lines are NOT monitored after business hours, so all maintenance emergencies must be reported using the phone number above!
